Advanced Clinical Preconference Track - 12:30 - 5:30 PM

When the Goal Is Comfort: Interdisciplinary Care During Oxygen Weaning at End of Life | Rachna Goswami, Palliative Care Physician & Kelley Newcomer, Medical Director, VNA Hospice of Texas | This session reviews the role of oxygen at end of life, the emotional impact on patients and families, and a practical approach to symptom control during planned weaning. Using case examples, we'll share interdisciplinary strategies and tools for anticipatory prescribing, family education, and team support to optimize comfort during oxygen withdrawal.

Documenting Signs and Symptoms – What Matters? | Linda Tavel, MD, Bristol Hospice | Is it possible that not every symptom or physical sign relates to a terminal condition? When is ankle edema or a new rash not noteworthy? This session will examine the assessment and reporting of physical signs and symptoms and their relevance to terminal conditions and comorbidities in hospice.

"We Do Do That" | Olivia Rogers, RN, CHPN, Chief Nursing Officer & Kelley Newcomer, MD, FAAHPM, Medical Director | VNA Hospice of Texas | Hospice is changing; that is something we can all agree upon, but how best to respond to the changing hospice patient? Patients today are coming to us with a host of high-acuity problems and high-tech equipment. The old adage of "that is not in line with hospice philosophy" is no longer going to meet the needs of today's hospice patient and family. Airvos, paracenteses, midlines, PICCs, palliative radiation, NOACs and more, this session will address how to find a way to say "yes", and how to educate the patient and family on treatment options and consequences.

Advanced IV Therapy | Marcus Zavala, Pharm.D., BCSCP, Chief Pharmacy Officer, Perrone RX & Perrone Pharmacy Inc. and Kelley Newcomer, MD, FAAHPM | This talk will review how to order appropriate IV therapies such as PCAs with opioids, managing patients on home inotropes, converting from PO to IV and back to PO, using off label IV formulas to control symptoms orally/sublingually, and more.

Social Worker Preconference Track - 12:30 - 5:30 PM

Beyond the Caseload: Empowering Social Workers in Hospice Leadership | Brianna Ahmiche, LMSW, Bridge Hospice | This session explores ways hospice social workers can expand and elevate their role beyond documentation, highlighting leadership competencies in bereavement support, substance-use risk assessment, safety planning, and community outreach.

Dementia and Effective Communication: Helping Caregivers Communicate | Kathy Miller, LMSW, Hope Hospice | This session equips hospice professionals with practical tools to educate caregivers on communicating with individuals living with dementia.

Unspoken Goodbyes: Supporting Teens Through Grief in a Digital Age | Brianna Ahmiche, LMSW, Bridge Hospice | This workshop provides trauma-informed, developmentally appropriate strategies to support grieving adolescents in hospice and community settings.

Ethical Documentation in Social Work: Should I Write This Or That? | Valencia Hooper-Alexander, LMSW, Bella Hospice | Documentation plays a vital role in social work practice, serving as the official record of events and interventions. The common adage, "if it isn't written, it didn't happen," underscores the importance of thorough and accurate recordkeeping.

Care | Steve Landers, MD, MPH | CEO of The Alliance for Care at Home | This session will explore the significant advances and positive developments transforming hospice and palliative care delivery in the United States. National Alliance for Care at Home CEO Dr. Steve Landers will examine key trends driving the success of the field, including expanded access to care, innovative care models, and increasing recognition of palliative care's role across the care continuum. Participants will gain insights into emerging opportunities, policy developments, and evidence-based practices strengthening the hospice and palliative care workforce. The presentation

will conclude with a discussion of how providers, policymakers, and advocates can build on current momentum to improve patient outcomes and expand quality end-of-life care. A-1 | "To Poo or Not to Poo ... A Surgeon's Memoirs on Constipation"

Philip Hamby, MD, FACS & Romeeka Siddique, MD, Hospice and Palliative Care Fellow | Texas Tech University Health Science Center | This is a review of constipation particularly as it relates to the hospice and palliative care patient. The presentation is written from the perspective of a surgeon who is currently training in hospice & palliative care. It provides a workflow for helping patients who cannot pass stool and those who are truly "full of it." The presentation is designed to provide practical and memorable advice for the management of constipation primarily for the hospice RN and the hospice physician. *Audience: All | Level: General (Everyone)*

A-2 | "All to do with HR (Staffing, Retention, Background Checks, etc.)"

Janet Gomez, LMSW, Alt. Administrator | Pax Et Vita Hospice Agency, LLC | Successful hospice care begins with building a workforce that reflects both clinical excellence and organizational values. This session explores effective strategies for recruiting and retaining the right candidates beyond the interview stage, including values-based screening, reference verification, and competency assessments. Attendees will learn proactive retention techniques such as employee satisfaction reviews, open-door leadership practices, and transparent communication that fosters trust and long-term commitment. The session will also outline key compliance and quality practices, including timely background checks, re-screening requirements, and structured annual and bi-annual personnel file reviews, along with updates to policies, emergency preparedness plans, business profiles, and QAPI initiatives to ensure ongoing regulatory readiness and organizational excellence. *Audience: All | Level: New to Hospice*

A-3 | "The Missing Conversation: End-of-Life Planning for People with Disabilities"

Arielle Friedtanzer, End-of-Life Consultant | Parents of children with special needs often fear a future when they can no longer provide care. Yet conversations about aging, death, and personal values rarely include adults with intellectual disabilities. Communication barriers and limited training among healthcare professionals contribute to this gap, risking end-of-life care that does not reflect individuals' wishes. This session explores why these conversations aren't happening, and what we can do to change that. *Audience: All | Level: General (Everyone)*

A-4 | "Ethical AI Governance in Hospice and Palliative Care: Balancing Innovation with Compassion"

Analytics | Axxess | Artificial intelligence has the potential to transform hospice and palliative care by improving staffing, symptom management, patient engagement, and resource allocation. Tools such as predictive analytics, decision support, and automation can help clinicians overcome time and communication challenges. However, AI use in end-of-life care raises important ethical, governance, and trust considerations. This session reviews the current landscape of AI in hospice and palliative care and best practices for using AI tools within electronic medical records.

B-1 | "The Power of Charting with Conviction; Active Documentation for Hospice RNs"

Amy Cooley, RN, CHPN | Tribute Hospice and Palliative Care | Discover the Power of Charting with Conviction! This engaging seminar is designed exclusively for hospice nurses who want to strengthen their voice through documentation. Learn how active, precise charting not only protects your patients and your practice but also reflects the true depth of your care. We'll explore strategies to streamline notes, highlight clinical judgment, and confidently capture the art and science of hospice nursing. B-2 | "Seven Dumb Mistakes Smart Hospice Professionals Make"

Attendees will leave with new awareness and tools to enhance compassion, professionalism, and quality care in the hospice setting. B-3 | "Aging, Sex, and Consent"

Brianna Ahmiche, LMSW | Bridge Hospice | Sexuality and intimacy remain vital parts of life at every age, including for patients receiving hospice and palliative care. Yet conversations about sex and consent in older adults are often overlooked, misunderstood, or avoided. This avoidance leads to ethical dilemmas, safety concerns, and unmet needs. This presentation explores how ageism, cognitive decline, and cultural taboos shape discussions of intimacy in aging populations. Participants will learn to identify red flags around capacity and consent, balance patient rights with safety concerns, and foster culturally sensitive, trauma-informed approaches to intimacy at the end of life. Through case studies and practical strategies, attendees will gain tools to support patients and families with compassion, dignity, and ethical clarity. Audience: All | Level: General (Everyone)

B-4 | "We Need to Talk: Improving Quality and Care in End-of-Life Communication"

Helen Bauer, BSN, RN, CHPN, End of Life Educator and Advocate | Hospice Navigation Services | Clear and compassionate communication builds trusted relationships with patients, families, care partners, and communities. This session explores how empathic and coordinated communication by the interdisciplinary team improves patient and family experiences, contributing to better CAHPS survey scores and STAR ratings. Attendees will examine the impact of ineffective communication and learn practical ways to communicate with clarity, empathy, and professionalism. *Audience: All | Level: General (Everyone)*

C-1 | "Nausea: Helping to Keep it Down"

Thuy Hanh Trinh, MD, FAAHPM, HMDC, Team Physician | Houston Hospice | Nausea is often a side effect of curative medications and can be persistent and debilitating for patients. This session will explore medical management options to help alleviate symptoms while safely titrating medications to optimize comfort. Participants will also learn strategies for counseling families about decreased oral intake, the physical changes associated with cachexia, and how to provide reassurance that symptom management remains focused on comfort and safety for both patients and their families. *Audience: All | Level: New to Hospice*

C-2 | "A Workforce Under Strain: After-Hours Models That Prevent Clinical Burnout"

Bernadette Smith, VP of Marketing | IntellaTriage | With burnout and attrition among the biggest threats to hospice access, this session highlights innovative ways to support clinician work-life balance without sacrificing patient care. In hospice and home health, there are really three core after-hours care models, each with different impacts on nurse burnout, patient experience, and operational efficiency. Learn how different after-hours triage models impact fatigue, retention, and costs. Allow clinical teams to thrive in the roles they were trained for. This talk will share data from agencies who've adopted different approaches, including before-and-after impacts on morale and scheduling. *Audience: Supervisors/Managers/Leaders | Level: Intermediate*

C-3 | "Communication Strategies Across the Stages of Dementia"

Hollie Lowe, MA, LPC, NCC, Director of Education and Family Support Services | James L. West Center for Dementia Care | This session explores how communication abilities evolve throughout the stages of dementia and offers practical, compassionate strategies to support meaningful connection at every phase of the disease. Participants will gain insight into how dementia affects language, comprehension, and expression in the early, middle, and late stages, including both verbal and nonverbal communication changes. Evidence-based techniques will be shared to enhance understanding and reduce frustration, such as simplifying language, validating emotions, using visual cues, and incorporating supportive tone, touch, and body language. Real-world examples will demonstrate how thoughtful adjustments in communication can strengthen relationships, promote dignity, and improve quality of life for individuals living with dementia and those who care for them. *Audience: All | Level: General (Everyone)*

C-4 | "Symptom Management for Hospice Patients with Psychiatric Diagnoses"

Linda Tavel, MD, Medical Director | Bristol Hospice | It seems more patients are coming to hospice with psychiatric diagnoses in addition to their terminal conditions: schizoaffective disorder, MDD, schizophrenia, others. Their medications permit function and high-quality life experiences. Stopping or weaning these medications requires intentional case management. Also, as symptoms typical for hospice patients arise such as nausea, anxiety or delirium, drug interactions are a concern. The session will examine the role and management of patients' psychiatric medications as they journey.

D-1 | "Hospice Comfort Kits: Helpful or Harmful?"

Lauren Templeton, DO, FAAHPM, HMDC, Consultant Physician, Pennant Group & Weatherbee Resources, & Ellen Fulp, PharmD, MSPC, BCGP, FAAHPM, Pharmacist, Parella Health | Symptom management is a standard right of hospice patients. Hospices are tasked with developing individualized plans, including managing troublesome symptoms, considering each patient's unique needs and preferences. The Centers for Medicare & Medicaid Services (CMS) highlighted adequate symptom management as an area of quality improvement for hospice agencies and developed the Hospice Outcomes and Patient Evaluation (HOPE) tool as part of the Hospice Quality Reporting Program (HQRP). Appropriate symptom assessment visits, treatment plans, and 24/7 access to the hospice team enable effective symptom management. Considering the importance of timely symptom management to decrease suffering, for many hospice agencies, it's common practice to introduce a small quantity of medications for the management of new symptom onset. This session will highlight the potential benefits, harms, and best practices associated with planning for aggressive symptom management at end-of-life. *Audience: All | Level: General (Everyone)*

D-2 | "Designing a Compliance Driven Culture - Why We Need a Compliance Program"

Richard Y. Cheng, Esq., CHC, Managing Member | Ritter Spencer Cheng, PLLC | This session introduces the foundations of hospice compliance and examines how a strong compliance program not only protects an organization but also serves as a strategic advantage. Attendees will explore the seven essential elements of a compliant program and learn how to build, implement, and sustain effective processes that support ethical operations and regulatory adherence. Discussion will include practical examples of risk assessments, ongoing monitoring, auditing practices, and corrective action planning to prevent issues that could trigger government investigation or enforcement. Participants will also gain insight into how compliance impacts Medicare reimbursement, as well as key considerations for compliance management during mergers and acquisitions, ensuring operational integrity and long-term organizational value. *Audience: All | Level: General (Everyone)*

D-3 | "Toxic Empathy: When Compassion Goes Too Far"

Jerry Fenter, System Director of Spiritual Counselors | Harbor Healthcare System | This presentation will introduce leadership and management, as well as the professional caregiver to the concept of toxic empathy (also known as toxic altruism). While empathy and compassion are the backbone of effective hospice care, excessive or unregulated empathy can become harmful—to the care system, the team, patients and families, and the individual caregiver. The session will use real-world scenarios to illustrate how toxic empathy develops, the negative consequences that result when it's unchecked, and strategies to identify and manage these patterns for healthier, more resilient caregiving. *Audience: All | Level: General (Everyone)*

D-4 | "Palmetto GBA Workshop (Billing and Medical Review)", VIRTUAL SESSION Charles Canaan & Dan George, Senior RHHI Ombudsman and Senior Medical Review, Palmetto GBA | This series equips hospice providers, billers, administrative staff, and clinicians with essential tools for mastering Medicare billing and documentation. Attendees will gain practical skills and insights to ensure compliance and success in navigating Medicare requirements.

This interactive presentation uses familiar children's stories to reveal common communication breakdowns in healthcare and the ethical problems they can create. Together, we'll explore practical strategies drawn from these stories to improve communication with patients and colleagues and prevent conflicts before they arise.

E-1 | "Revisiting Pain Management in Children"

Ana M Montanez, MD, Hospice and Palliative Care Fellow & Kelly Klein, MD, Hospice & Palliative Care Director |

Texas Tech University Health Sciences Center Lubbock | Pain is one of the most common complaints in children, yet assessing and managing it has long been a challenge in pediatric care. While efforts to reduce opioid prescribing have helped address overdose risks, they may also contribute to the undertreatment of pain when opioids are appropriate. This session will review evidence-based guidelines for a balanced, multimodal approach to managing acute and chronic pain in children. Audience: All | Level: General (Everyone)

E-2 | "HOPE Lessons Learned: Where We've Been & Where We're Going"

Samuel Pate, Sr., Client Development Representative | Simple, a Netsmart Solution | As hospice providers transition into the first months of using the new Hospice Outcomes and Patient Evaluation (HOPE) tool and CMS reporting systems, valuable lessons are emerging that shape compliance and care delivery. This session reviews early experiences with HOPE implementation, including changes to daily workflows, the use of iQIES for data submission, and the real-world impact of new regulatory requirements. Attendees will explore strategies to streamline documentation and reporting, enhance accuracy, and prepare for the two new hospice quality measures tied to HOPE. E-3 | "Call to Duty - Serving the Veteran Population in Texas"

Edward Tello, Veteran Liaison/Bereavement Manager | CREST PALLIATIVE CARE | Texas is now home to the largest veteran and military population in the nation, making focused attention on the needs of this community both timely and essential. Veterans face unique challenges, including elevated suicide rates and low utilization of hospice and VA-assisted end-of-life care. As Baby Boomer veterans reach advanced age, we are simultaneously honoring the final years of WWII veterans while actively caring for Vietnam-era veterans and those entering the Gulf War era. This session will introduce attendees to veteran culture and lived experience, explore the needs of veterans and their families, and provide an overview of the VA system and its role in supporting veteran care. *Audience: All | Level: General (Everyone)*

E-4 | "Care Coordination and Hospice Services in Texas Medicaid"

G-1 | "Less is More: Deprescribing Basics and Beyond"

Specifically, rationale for deprescribing antidementia drugs, valproate drugs for dementia-related agitation, lipid-lowering drugs (e.g., statins), antiplatelet drugs, anticoagulants, cardiovascular drugs for primary hypertension, anti-diabetic drugs, inhalers, docusate, topical compounded gels and a few others will be discussed.
